Our 2+ acre campus in the heart of the Taos historic district contains the home, studios, and gardens of E. I. Couse and J. H. Sharp, two of the founders of the Taos Society of Artists. It is also home to The Lunder Research Center, a 5,000-square-foot museum facility that includes exhibition space, collections and archive storage, a research library, and curatorial and office space.

- Busloads of tourists would harm the integrity of the historic site and the unique experience.


COLLECTIONS & ARCHIVES

- About 1,400 objects in permanent collections, including 300 paintings and 900 artifacts; significant holdings of Spanish Colonial artworks and furnishings and of Indigenous artworks
- Photographs: More than 22,000 digitized stills, 12,000 prints, 10,000 negatives
- 195 paintings and works on paper by E. I. Couse, plus 36 sketchbooks
- 66 works of art by Taos Society of Artists members Kenneth Adams, Oscar E. Berninghaus, Ernest Blumenschein, Catharine Critcher, E. Martin Hennings, Bert Geer Phillips, Julius Rolshoven, Joseph Henry Sharp, Walter Ufer


OPERATING BUDGET

OUR PURPOSE

Through its archives, collections, and programming, the Couse-Sharp Historic Site preserves and interprets Taos' crossroads of cultures, promoting and facilitating research, education, and new perspectives on the Taos Society of Artists, early artists of Taos, and regional and Indigenous communities in relation to the greater story of the multicultural American West.

SPECIAL NOTE: CHARITABLE GIVING AND FEDERAL INCOME TAX

The Couse Foundation, which owns and operates CSHS, is a 501(c)(3) charitable nonprofit, so gifts to us are tax-deductible. Changes in 2025 to IRS regulations affect many donors. For example, non-itemizers will see an above-the-line deduction opportunity for charitable donations made in 2025. For itemizers, there will be a future floor on the charitable deduction and a limitation on the value of all itemized deductions for taxpayers in the top bracket. Many limitations do not take effect until 2026, so taxpayers may bunch their charitable giving in 2025. We encourage donors to consult their financial advisor, or a source such as the nonprofit Tax Foundation, to find out how your giving plans may be affected.
